MEMORANDUM FOR Students Attending 35 Series Training at 4/640th RTI starting in June 2020

SUBJECT: Letter of Instruction

1. If you are receiving this letter your unit has coordinated with 4th Battalion, 640th Regiment for you to attend a 35 series course.
2. Per COVID 19 precautions Soldiers must adhere to the following: All Soldiers attending a course at Camp Williams will adhere to DOD guidance regarding masks and the COVID vaccine. All Soldiers will need to bring a mask to class with them each day regardless of vaccination status. Each Soldier will wear a mask at all times while in doors in BLDG 3030.

a. Effective 15 December 2021, TRADOC requires all Students attending TRADOC schools for PME, MOS producing schools and functional training to be fully vaccinated prior to arrival. Although FRAGO 5 to HQDA EXORD 225-21 establishes 30 June 2022 as the suspense for the National Guard's and USAR's compliance with 100% vaccination, this is not an individual Soldier suspense. Combined with the Deputy SECDEF Memo, dated 24 September 2021, which restricts official travel for unvaccinated TRADOC has published all guidance regarding vaccinations in FRAGO 5 to TRADOC OPOD 21-014. All Soldiers who attend courses with 4th BN, 640th REGT (RTI) will need to produce proof of vaccination for the COVID 19 virus. Soldiers must produce either a CDC approved vaccination card, or verification from the Soldier's IMR to the Course Manager prior to arrival in Utah. Soldiers who travel without verification will need to produce either form of verification to the Course Manager immediately upon arrival. If a Soldier fails to produce verification of this vaccine requirement, that Soldier will immediately return home at the unit expense.

b. Open barracks are available at this time, and will only be issued to Soldiers in predetermined classes until further notice. Each student will be notified by the course manager from the course and informed whether their course will stay in the barracks at this time. Each Soldier that receives notice that they will be in open barracks will need to bring a padlock to secure their gear, uniforms and other personal items.

3. You must coordinate your transportation to Army Garrison Camp Williams. You should plan your arrival to Camp Williams at **1500 hours** on the report date for accountability at Building 3070. If you cannot arrive prior to 1500 hours please contact your course manager.

4. Rental Cars and POV. Due to the remote location of Camp Williams, coupled with the fact there is no on or off-post transportation, it is highly recommended that you request authorization to bring your POV or have a rental car authorized on your orders. Though this is a recommendation, it is not mandatory for attendance of any course offered in 4th BN, and authorization must be obtained from your home unit. See attached POV Justification Memo.

5. Army Writing. Courses taught with 4th BN 640th REGT all have differing degrees of writing associated with them. Students who attend class will write papers, reports, and analyze writing according to the Army's style of writing and in APA format. The United States Army Intelligence Center of Excellence (USAICoE) has several writing classes that students should conduct prior to arriving for class. Some of the suggested classes students should participate in include; **APA Formatting - the updated 7 version, Analysis - how to write analysis and the difference between analysis and summary, Comma Usage, Passive and Active Voice, Purpose - the why and BLUF, Run-on Sentences, Sentence Structure, Subject Verb/Agreement, Transitions in Essays, Using Google Docs, and Using Word.** This list is not all inclusive. It is **STRONGLY RECOMMENDED** that each student attend any course complete one or more of the above courses to help them with their writing ability. 6. Billeting.

a. On-Post Accommodations. Students residing outside of 50 miles of traveling distance to Camp Williams will have access to BEQ accommodations at \$22 per night. Due to the length and nature of the courses taught in 4th BN, it is **STRONGLY RECOMMENDED** that units take advantage of this option. Again, **open barracks are not available at this time except for predetermined classes.** Please coordinate with your unit administration promptly, and communicate with the Course Manager of the course you are attending, so they can make the necessary reservation for you. If you plan to stay in BEQ, contact the Billeting Office at (801) 878-5410 to confirm your reservation. They are open Monday through Friday 0900-1700 MST or Saturday and Sunday from 0900-1500 MST. Check-in is located on the first floor of Building 8300. You will need to register a credit card, preferably a Government Credit Card (GOVCC), upon check-in. If you do not have a GOVCC, you will be required to leave a deposit. Linen is provided, though you can choose to use your own. No Soldiers are allowed to check into the BEQ prior to 1400 on the day of check in.

b. All Soldiers chosen to stay in the open bay barracks, who have been identified by the course manager as staying in the barracks, **will be required access to Wi-Fi.**

Wi-Fi is available in the open bay barracks at a cost of \$30 a month and should be listed as an additional cost on the Soldier's DTS Travel Voucher.

b. Students living within a 50-mile radius of Camp Williams may opt to stay in BEQ, as provided on Camp Williams, while attending the course. Expenses associated with on-post housing will likely be out-of-pocket, and may or may not be reimbursed by your unit. It is incumbent upon the student to ensure they are aware of the expenses if funds are not available for reimbursement.

7. Travel Day (Day Zero). On your travel day **at 1500 hours**, report to building 3070 on Camp Williams to sign in and receive further instruction by the course cadre. Uniform is appropriate civilian attire. Students must park vehicles on the east side of Building 3070 in the dirt parking lot. This dirt parking lot is where student vehicles are to be parked throughout the entirety of the course.

8. Day One. In-processing will begin on the first day of class in building 3030 east entrance foyer at the time directed by your Course Manager. Duty uniform will be ACU's (with Occupational Combat Pattern). Required documents at in-processing are as follows:

- DD 1610 (DTS order) authorizing training attendance (or pay order for local Soldiers)
- DA 3349 Physical Profile if applicable (no temporary profiles for NCOES)
- DA 1059 for prerequisite courses
- Proof of MOS for all PME courses (e.g. DA 1059, DD 214, MOS Order)
- Applicable waivers
- Contact phone numbers for your unit 1SG, Commander, and unit administrator.
- DoD Cyber Awareness Challenge certificate (must be less than one year old by the completion of the course, the web address that you can use to complete the training is here: <https://iatraining.disa.mil/eta/cyber-awareness-challenge/launchPage.htm>)
- DA705 and applicable DA 5500/5501

Additional documents or further instruction may be annotated in the Course Information Memo for your specific course.

9. The PRCL should be completed by your unit in ATRRS prior to arrival at the training site. If your unit is unable to complete the PRCL, you must bring a Pre-Execution Checklist signed by your commander or someone with delegated signing authority & a copy of such delegation.

10. Clearance. You **MUST** have **US Access** of Top Secret (TS) listed in JPAS as well as be **READ ON** to SCI before arrival at the 640th RTI. If you do not have a TS you may be denied enrollment and be immediately returned to your unit; **the 72 hour rule does not apply**. Contact your local Site Security Officer/J2/G2/S2 to confirm your

caveats. If you are enrolled in Continuous Evaluation (CE) you must bring proof of enrollment. You must also have a current Common Access Card (CAC) and know your PIN. Ensure the card is valid throughout the entirety of your course.

11. ACFT and HT/WT. ACFT will be conducted on day 7 and will be for Diagnostic purposes only. Service Members attending ALC or SLC must bring a record passing DA 705 (and 5500/01 if necessary). Starting 01 May 2021 NCOES Courses will be conducting HT/WT IAW, AR 350-1 para 3-13. Passing HT/WT is a course requirement and will be conducted on Day 1 of the NCOA Course. Failure to meet standards will result in test re-administration within 10 days of initial testing. Failure to meet height and weight standards will result in dismissal from the NCOA course.

12. Return travel. Soldiers are released for return travel after 1300 on the final day of the course.

13. Uniform. Duty uniform is the ACU. Should the 640th RTI deem the weather too cold for wearing the patrol cap, the only authorized cold weather headgear for the 640th RTI is the micro-fleece cap. Fall and winter in Utah is generally from September to late March. Temperatures ranging from below freezing to mid-40 during the day and stay below freezing at night. Spring and summer is generally from April to September. Temperatures range from 80 to 105 degrees during the day and low 60s at night. It is recommended you bring civilian clothing for non-POI time. Dress appropriately.

14. MWR and Amenities.

a. Camp Williams billeting has wireless internet capability, free of charge, for those staying on post; you are encouraged to bring electronic devices capable of utilizing this service. The Internet connection is capable of allowing e-mail communication, but is not sufficient to perform tasks such as streaming video. Computer labs at Building 3030 are also available for research and personal use. Laundry facilities are readily available on AGCW at no cost to the student. There is a fitness center on AGCW as well as an AAFES Post Exchange/Class VI.

b. The 640th REGT hosts a 26.2 Mile Ruck March Challenge for students during their time while in attendance in any course. This challenge is in no way a mandatory event. Each Soldier who chooses to take part in the REGT ruck challenge requires a \$50 fee, and a 35lb ruck sack or back pack. Soldiers who register must complete a total of 26.2 miles throughout their stay on Camp Williams. All 26.2 miles do not need to be completed in one iteration, Soldiers can break up the distance into multiple iterations. Each Soldier will maintain a log of their distances and upon completion present the log to their Course Manager for final approval. Each Soldier who takes part in this challenge will receive a finisher's medal at graduation, and a positive comment on their 1059 under the special projects or papers section. Register for the challenge through the

Course Manager during in-processing. This challenge in no way will increase a Student's academic rating for the course. See attached flyer for details.

15. Student Contact Info. If there is an emergency and it becomes necessary to contact you during training hours you may be contacted via your Course Manager. If an emergency is severe enough to cause you to leave the course, an official notice will need to be sent to the 640th RTI through the American Red Cross. You may use your personal cellular phone during lunch or in the evenings once training has concluded for the day. 16. College Credit Opportunities. 4th BN, 640th Regiment (RTI) has partnered with both Utah Valley University and Cochise Community College to provide college credits for completion of military intelligence courses attended at Camp Williams. Questions about either program can be directed to the Course Manager for the course you are attending.

a. Utah Valley University is the largest University in the State of Utah. It is accredited by the Northwest Commission of Colleges and Universities and offers Master's, Bachelor's and Associate degrees. Credits are awarded from the National Security Studies Program currently offered at UVU. Charges include an admission application of \$35, with subsequent tuition charges of \$20/credit hour (a 90% discount from the standard tuition rate).

b. Cochise College is a Community College located in Sierra Vista, Arizona. It is accredited by the Higher Learning Commission of the North Central Association. Registration and tuition fees for Cochise College credits are a flat rate of \$60 for any military intelligence course attended.

17. Per Diem. Students will receive meal cards, and be given access to the DFAC on Camp Williams. M&IE per diem allowance will not be required on their DTS, except for the \$5 incidental. *During certain phases, the 35M10 and 35L20 courses conduct operations off-post. (*Off-post courseware is currently modified to support CDC guidelines and Utah state health restrictions.)

SUBJECT: Statement of Transportation Availability

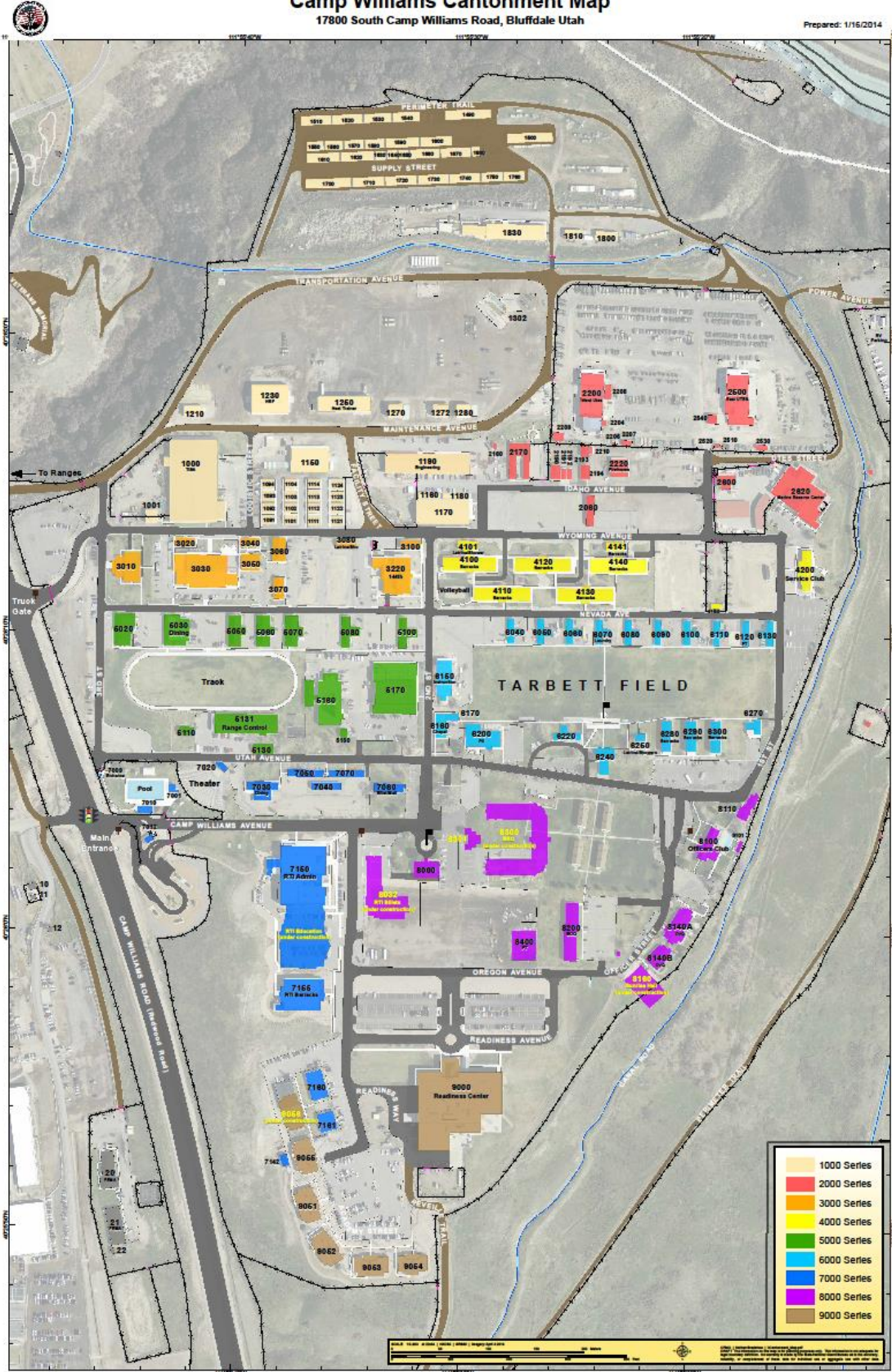
1. Camp Williams is located 32 miles from downtown Salt Lake City. There is no off post transportation provided and there are no amenities within a reasonable walking distance from Camp Williams.
2. The MWR facilities on Camp Williams are limited, consisting of a single day room/Soldier Center, AAFES Post Exchange with no clothing sales or restaurants, Soldiers Club, weight room and outdoor pool (open during summer months). There are many recreational activities available in the areas surrounding Camp Williams, however, there is no transportation provided on and off post.
3. Due to the duration of MI courses, the limited MWR facilities available, and the remote location of Camp Williams, it is highly recommended that Soldiers attending school be authorized either a POV or a rental car. However, rental cars and POVs are not required for the courses and reimbursement is entirely at the discretion of the Soldiers' unit or state.
